



Three Cord Marriage Coaching Agreement

Coaching

1. Three Cord Marriage coaches are adept in the coaching skills of listening, asking questions, sharing their life experiences, and most importantly, understanding the issues you are facing. Their goal is to equip and empower you to experience true unity and live into your marriage's divine purpose. While coach couples are not lawyers, licensed counselors, therapists, or psychologists and do not provide marriage or family therapy or legal advice, they can facilitate significant improvements in many relationships.
2. Coaches will guide you through mindset, individual, and marital self-discovery conversations and exercises, but the results of these conversations and exercises depend on your commitment to learning and applying the skills.
3. Although many couples report improved relationships as a result of coaching, there are no guarantees about the success of the coaching process in your unique situation. Change and growth are hard work and are best accomplished when you work together as a team.
4. Conversations with your coach couple will be held in confidence with three possible exceptions: 1) possible referral to other coaches and professionals for guidance or direction or 2) reporting suspected abuse of children, the elderly or mentally ill or 3) reporting suspected intent to harm oneself or others including children, the elderly, or mentally ill.
5. Three Cord Marriage is a faith based 510(c)(3) organization that provides services for the purpose of demonstrating Christ's love and moving couples toward a biblically based marriage of one man and one woman.

Three Cord Marriage will provide coaching services at a rate of \$100.00 per hourly session. The quantity and frequency of the sessions will be based on the clients' needs, progress, and as agreed to between client and coaches.

Payment for services are due in full at the time of the scheduling of the appointment.

Client may reschedule sessions no less than 48 hours in advance of the scheduled appointment without penalty.

Appointments rescheduled within 48 hours of the scheduled appointment may be assessed a \$25 rescheduling fee.

Appointments may be cancelled no less than 48 hours in advance of the scheduled appointment and will be assessed a \$25.00 Cancellation Fee.

Appointments cancelled within 48 hours of the scheduled appointment are not subject to a refund.

No-shows for appointments will not be rescheduled and are not subject to a refund.
